Abstract:

Since its publication in 1884, critics have persistently debated the topic of agency in Leopoldo Alas' novel La Regenta. To some the novel's characters seem incredibly rational and endowed with heroic moral responsibility, while to others they provide evidence of social constructivism, the result of the author's engagement with French nationalism. A review of these debates over time shows patterns that fluctuate according to ideological positions that transcend rather than simply reflect the novel's

biases. For the novel to continue to be a forum for debate, however, critics may have to move beyond these debates as they are usually framed and engage in a more theoretical discussion of social agency in order to arrive at a more precise conception of how social identity is attained.

Abstract:

This article analyzes how a young Salvador Novo established himself as a chronicler and public figure 1920's Mexico City. Through the lens of a polemic that took place between Novo and Ruben M Campos in the weekly El universal ilustrado in 1929, this essay reads Novo's turn to the chronicle as his response to the debates on the "feminization" of literature which galvanized Mexico's intellectuals in the aftermath of the revolution. Novo conceives of the chronicle as a genre that performs both the "masculinity" of literature and the "femininity" of mass culture. Doubling as a temptress or a prostitute, the chronicler strips literature of its aura, making it desirable, irresistible, and public. As a chronicler, Salvador Novo works by engaging readers and drawing them in as sexual/textual accomplices to inscribe literary style into the public sphere.

Abstract:

This article draws on the early work by Gilles Deleuze in order to elucidate some key aspects relating to the representation of subjectivity in Terenci Moix's three-volume autobiography El peso de la paja. It starts by looking at Deleuze's notion of the subject as a "simulacrum" of Being and as a mere "impersonal consciousness" (Jean Khalfa). Drawing on Alain Badiou's and Slavoj _i_ek's respective readings of Deleuze, it analyzes the philosopher's notion of thought as an "ascetic" process whereby the individual is "transfixed" by the "impersonal exteriority" that is also considered to be his or her most authentic being. Against this theoretical background, the article then turns to Moix in order to interpret the author's renunciation of love in favor of literature at the end of his own personal apprenticeship—among other aspects of his autobiography— as a turn toward a domain of virtual transcendence, one which leads Moix to attain "intellectual beatitude" conceived as "the enjoyment of the Impersonal."
